As the COVID-19 situation continues, DOC would like to provide you with updated information. As of December 26, DOC **statewide** has:

- 21 AICs who currently have COVID-19

Employees who have tested positive are not reporting to work. All adults in custody who have tested positive are being medically isolated at a facility that provides medical care.

The Prison Fellowship Academy is coming to SRCI in 2023. Are you looking for skills and supports to help you make a lasting change? You might be ready for the Prison Fellowship Academy, a proven program that takes you on a journey to:

- Target negative thinking and behaviors at the root
- Understand victim impact
- Learn important life skills
- Build relationships with program leaders and other men on a road to success



### **PROGRAM REQUIREMENTS:**

- The Academy uses curriculum based on Christian principles and values, but welcomes people of any/no religious preference.
- You must have more than a year left on your sentence to complete the 12 month program.
- You will be expected to commit to all the program requirements, including assignments and on-time attendance for day-time and/or evening classes.

You will be expected to follow institution rules and regulations, and treat staff, volunteers, and other participants with consideration and respect.

Classes will meet 3 times per week (10 hours per week) during the day. Classes also meet 2 evenings per week for volunteer-led classes.

## **From the Administrative Rules Program:**

Below is the list of status changes made to DOC administrative rules since 11/7/2022.

### **PROPOSED RULES:**

#### **291-117 Authorized Inmate Property**

Amends rule to remove gender-based language and to bring the rule into alignment with current operational practice.

Last day to provide comments: 2/7/2023 at 5:00 PM

### **TEMPORARY RULES:**

#### **291-105 Prohibited Conduct and Processing Disciplinary Actions**

Amends rule to reduce the maximum consecutive sanction to DSU from 180 days to 90 days.

Effective 1/1/2023 through 6/29/2023

#### **291-069 Security Threat Management**

Amends rule to update and clarify for staff and adults in custody the identification of adults in custody that present an elevated security threat risk for early intervention and Security Threat Management (STM), including expressly authorizing in the rules the department's utilization of risk assessment tools.

Repeals Attachment A - High Alert Adult in Custody.

In partnership, Library Services and Business Offices would like the following verbiage added to AIC newsletters:

## **2022 Taxes & Forms**

DOC will not be providing Adults in Custody (AICs) with tax forms.

It is recommended that AICs obtain appropriate tax forms (*IRS Form 1040 / Oregon Form OR-40, etc.*) and instructions from a trusted source outside of the institution.

AICs will need to use their own pre-addressed, postage paid envelope(s).

AICs may appoint a qualified and trusted person as their power of attorney (POA) to assist with the tax filing process. POA forms can be obtained by submitting a Library Request form (CD1714).

Department staff may not provide tax advice to AICs.
