
## Candy Oatmeal Cookies



**Ingredients:** 2 heaping tbsp peanut butter  
1 Three Musketeers candy bar  
3 (43 grams) pkgs regular oatmeal  
3 (43 grams) pkgs maple brown sugar oatmeal  
1 pkg plain M&M's  
3 tbsp hot water

**Directions:** In a clean small chip bag combine peanut butter and the Three Musketeers. Place in a hot pot so that all can fully melt. While waiting, in a spread bowl combine all the oatmeal, M&M's and hot water. After ingredients melt, pour into the spread bowl, mix, and knead well. 

Subject: Federal Student Loan Debt Relief

If you are an AIC with federal student loan debt, you are likely aware President Biden has promised to forgive those loans if you are eligible and fill out an application.

Unfortunately, courts have issued orders blocking the student debt relief program. As a result, applications are not being accepted at this time. The U.S. Department of Education is seeking to overturn those orders.



Si se anulan los pedidos y se aceptan nuevamente las solicitudes, se lo haremos saber y le proporcionaremos más información y formularios de solicitud.

### Reminders:

Soda tickets will only be credited if an AIC has been transferred to a different facility. The AIC has 30 days from the date of transfer to submit an AIC communication form requesting a credit from the commissary where the soda tickets were purchased. You must include the unused soda ticket(s) and a receipt as proof of purchase. The receipt may not be more than 90 days old from the date of the request. Commissary will not issue credit for damaged tickets or issue credit if the soda machine takes your ticket without dispensing a soda. The use of the soda machine is at your own risk.

***From the Administrative Rules Program:***

Below is the list of status changes made to DOC administrative rules since 10/25/2022.

**PROPOSED RULES:****291-121 Handiwork**

- Repeals the Handiwork rule OAR 291-121 and replaces it with the Learning Entrepreneurship, Arts, and Production (LEAP) Rule in order to allow for more institutions to participate in entrepreneurial programs. The Handiwork OAR 291-121 is outdated and does not allow for the Department of Corrections to expand AIC entrepreneurial craft type of sales to other locations.
- Last day to provide comments: 12/23/2022 at 5:00 PM

**291-172 LEAP - Learning Entrepreneurship, Arts, and Production**

- Adopts guidelines at participating institutions for a program allowing adults in custody to constructively use non-programming time to engage in a positive learning experience with the possibility to earn funds for use during incarceration or after release. This rule OAR 291-172 LEAP will replace OAR 291-121 Handiwork (AIC), which will be repealed.
- Last day to provide comments: 12/23/2022 at 5:00 PM

**TEMPORARY RULES:****291-124 Health Services**

- Amends rule to establish circumstances in which the Department of Corrections will provide medically acceptable durable medical equipment (eyeglasses, medical prostheses, and hearing aids) at state expense, to adults in custody, and procedures concerning the provision of repair and maintenance of that equipment.
- Effective 10/26/2022 through 4/23/2023

**PERMANENT RULES:****291-031 Community Corrections Programs**

- Amends rule to (1) clarify requirements specific to the submission timeframe for the biennial community corrections plan, (2) update definitions of the funded workload as a result of SB497 (2021), (3) replace the term "offender" with the "adult on supervision" and (4), make necessary housekeeping changes as a result of changes in business practices as well as those identified during the DOJ review.
- Effective 11/7/2022

- Please remember to bring any legal material, or envelopes (if doing a mail-out or notary) to your appointment with a legal assistant.
- Please fill in all portions of the "Law Library Request Form" CD 1174 kyte, including any deadlines, schedule conflicts, case numbers, and the subject of your appointment.
- For those adults-in-custody who wish to pursue Senate Bill 819 requests through the Law Library please make sure to request your programming and disciplinary history from Mrs. Havelly, Public Information Officer for WCCF before any appointment for SB 819 Petitions, as well as copies of your judgment from Mrs. Conley, Records. This will help in filling out the SB 819 petitions.
- Currently, the General Library Checkout is unavailable. This will continue until changes are made to allow checkout to resume.
- New Materials have been added to each unit's "Resource Binder", consisting of a list of available forms you can order with a kyte to the Law Library (CD 1174) with a signed CD-28 for the cost of the form (\$.10 per page, for each form). Just send us a kyte with the price/cost, and form number (e.g., Form #03.020) of the form you want on the list, with the CD-28, and we will send you a copy of the form in the kyte system. We no longer will call you out to pick up a form.
- Please be patient with scheduling, as we are revamping our law library and system. Thank You.

## WCCF MAILROOM

- **MAIL VIOLATIONS** - unopened mail vs. opened mail
  - Unopened mail may have one or more reasons to be rejected. In this instance, a sticker is produced to return to sender with a brief explanation why & AIC **will not** get a paper notification.
  - Opened mail will result in a paper mail violation, gets distributed to both the sender and the recipient with details. Unless it is AIC to AIC, then only the sender gets a paper mail violation, not the recipient.
- **291-131-0015 (5)** Excluding weekends and holidays, incoming and outgoing correspondence should be processed within two days of receipt; publications and packages within four days of receipt; unless the mail is being reviewed for possible violations. **There are no time frames for conducting reviews.**
  - Please keep in mind that items being reviewed are scanned to Salem for a final determination.
  - Mailroom staff follow the above mail rule. We have roughly 48hrs for letters & newspapers; 96hrs for magazines and books. We do our best to go through everything, well before the deadlines.
- Incoming mail hits different check points before it gets to Lakeview. If your family/friends say it shows delivered, that does not mean it was delivered to WCCF. Please be patient.
- **AIC TO AIC MAIL REMINDERS:**  
291-131-0020 (5) (a) Inmates are authorized to correspond with other inmates if the correspondence is otherwise in compliance with department rules.  
(A) **Inmates may send only the following items to another inmate:**  
(i) Correspondence; (ii) One drawing per envelope; and (iii) One photograph per envelope.

If you have been given special permission to receive an item, wait until the package authorization is complete and the mailroom has been notified before having the sender mail the package.

If the item arrives, and the mailroom has not received the package authorization, the item(s) will be returned.

291-131-0025 (9) Packages, except books, magazines, and newspapers received directly from the publisher or distributor, require prior authorization from the functional unit manager or designee. The package authorization form must be attached to the outside of the package.


*In the event an AIC is not able to review a response from Financial Services, AICs may resubmit an electronic communication after the tablets are back online or utilize a paper AIC communication.*

Changes are coming that will impact all adults in custody (AICs) within the Oregon Department of Corrections, and we need your help.

Within the next 12 to 18 months, DOC will be implementing a new AIC custody classification tool. The new tool will pull data from each AIC's risk assessment on file.

Normally, risk assessments are completed at intake by the Intake Counselors. Institution Counselors update the risk assessments for all AICs assigned to a high/moderate caseload. AICs assigned to a low Automated Criminal Risk Score (ACRS) caseload (also referred to as case bank), do not receive updated assessments as they are not eligible for counseling services.

A small percentage of you do not have a current assessment on file. You will be called out for an assessment in the near future. It is important AICs watch their callouts on a regular basis, but it is even more critical now as DOC has a limited time to conduct these assessments. If you have a question or conflict, talk to the Officer on your unit.

Para: Todos los adultos bajo custodia

De: División de Servicios Correccionales, Equipo de Administración de Casos Correccionales

Se avecinan cambios que afectarán a todos los adultos bajo custodia (AIC) dentro del Departamento de Correcciones de Oregon, y necesitamos su ayuda.

Dentro de los próximos 12 a 18 meses, el DOC implementará una nueva herramienta de clasificación de custodia AIC. La nueva herramienta extraerá datos de la evaluación de riesgos de cada AIC en el archivo.

Normalmente, las evaluaciones de riesgos son completadas en la admisión por los consejeros de admisión. Los consejeros de la institución actualizan las evaluaciones de riesgo para todos los AIC asignados a un número de casos alto/moderado. Los AIC asignados a una baja carga de casos de Puntaje de Riesgo Penal Automatizado (ACRS) (también conocido como banco de casos), no reciben evaluaciones actualizadas ya que no son elegibles para servicios de asesoramiento.

Un pequeño porcentaje de ustedes no tiene una evaluación actual en el archivo. Se le llamará para una evaluación en un futuro próximo. Es importante que los AIC vigilen sus llamadas regularmente, pero es aún más crítico ahora que el DOC tiene un tiempo limitado para realizar estas evaluaciones. Si tiene alguna pregunta o conflicto, hable con el oficial de su unidad.

**Subject:** Performance Recognition Award System (PRAS) Revisions

**Status of PRAS revisions:** In 2014, the Department of Corrections (DOC) received a petition from an AIC to amend the PRAS Rule (OAR 291-077) so monetary awards align with costs of living. While the petition was denied as it was too complex, DOC formed a PRAS Audit Workgroup to address the petition and other concerns. These included points assigned for work and programming, and improving the work and training history letter AICs receive at release.

**The good news:** The DOC Executive Team approved Workgroup recommendations to satisfy the petition as well as eliminate several discrepancies in the PRAS rule. These changes create PRAS consistency throughout the department.

**The bad news:** Change takes time. Making the improvements required new PRAS system technologies, databases, and tracking systems to replace outdated originals. Due to several high-priority challenges (COVID-19, staffing issues, etc.), the necessary changes were nearly impossible. In addition, the consumer price index (CPI) caught up with the routine increases of average PRAS points, and canteen prices increased due to supply chain issues.

**The best news:** The Workgroup has been steadily making progress. In 2019, DOC eliminated the 120-day wait period to earn PRAS. The Workgroup is now ready to implement more changes.

**What does this mean to you?** Over the next few months, you will see the following changes:

- The PRAS matrix will be adjusted to create a more even point spread in the first three levels. Also, two more levels will be added to reduce the chance of “maxing out.” In addition, there will be an overall 25% increase in the dollar value of each level of the PRAS matrix to counteract the effects of the CPI and canteen increases. This will be accomplished through temporary rule adoption, effective 01/01/2023.
- The number of PRAS points awarded per position will be consistent at all DOC institutions. AICs will earn the same number of PRAS points for the same work, regardless of location. This will not happen all at once, as there are over 15,000 assignment possibilities.  
Start date: 12/01/2022. Estimated completion date: 06/30/2023.
- Improvements to the Work and Training History document you receive upon release will be implemented when the position realignment is completed.  
Estimated start date: 06/30/2023. Estimated completion date: 07/31/2023.
