

# **NINTENDO SWITCH UPDATE FROM THE RECREATION DEPARTMENT**

**\*\*AIC's are now able to purchase Nintendo Switches, Accessories and Video Games. This will all be done solely through *Fully Loaded Electronics*. The statewide process for ordering is listed below\*\***

## **Process for ordering a Nintendo Switch, Accessories & Video Games:**

- AIC must fill out a CD 1925 (Nintendo Switch Lite & Accessories form) or CD 1927 (Nintendo Switch Lite Game Order Form). Forms are available at your unit control point.

### **Steps For Ordering:**

1. Fill out a kytic stating that you would like to order a console, accessories, or games. Then send the kytic to Recreation stating that you would like to place an order for a Nintendo Switch, games, or accessories. **PLEASE DO NOT SEND YOUR ORDER FORM WITH YOUR KYTE. \*\*For new Nintendo Switch console purchasers, you may now order games and/or accessories at the same time\*\***
2. Once Recreation receives your kytic, you will be called down to Recreation; please bring your form(s) with you, where the following will be verified; Identification, Incentive Level 3, Items ordered and console ownership; if ordering games/accessories. **DO NOT ATTACH FORM TO A KYTE AND DO NOT HAVE YOUR UNIT OFFICER STAMP THE FORM; IT WILL BE STAMPED BY THE RECREATION DEPT.**
3. If you wish to order the full 3-year warranty, this must be done at the time you purchase your Nintendo Switch. You cannot purchase the warranty if you already own a Switch. **All current Nintendo Switch owners do not qualify for this warranty.**

- Once your order is verified by Recreation, the order form will be sent to Central Trust. Central Trust will then place the order with *Fully Loaded Electronics*. After 4-6 weeks (Depending on demand) FLE will ship your items to the Recreation Department. Recreation will distribute the items with a receipt accordingly.
- **Recreation and TRCI will not be accepting specific requests for game titles nor changes to the Nintendo Switch program**
  - **PLEASE NOTE: Any request of the above nature must be directed to FLE only**
- **All warranty issues will be handled by Fully Loaded Electronics; FLE will continue to provide repairs but will not be providing Downloadable Content (DLC) or updates.**

## **2022 Taxes & Forms**

- DOC will not be providing Adults in Custody (AICs) with tax forms.
- It is recommended that AICs obtain appropriate tax forms (*IRS Form 1040 / Oregon Form OR-40, etc.*) and instructions from a trusted source outside of the institution.
- AICs will need to use their own pre-addressed, postage paid envelope(s).
- AICs may appoint a qualified and trusted person as their power of attorney (POA) to assist with the tax filing process. POA forms can be obtained by submitting a Library Request form (CD1714).
- Department staff may not provide tax advice to AICs.

## TRCI Recreation Concert - “Matter of Time”

On Tuesday December 22, 2022, the TRCI Recreation Department hosted the first of a series of three concerts it will be putting on over the next three months. ‘Matter of Time’, a rock band of AIC’s, performed for TRCI’s General Population with an open invitation to Staff Members. Matter of Time’s members consist of AIC’s Mike White (Bass), Rocky Stinger (Lead Guitar, Back-up Vocals), Sean Riggs (Rhythm Guitar, Back-up Vocals), Thomas Urvina (Lead Singer) and Damon Hoyer (Drums).

The concert, which took place in TRCI’s visiting room, started at 1 p.m. and went until 2:30 p.m. The band played a wide range of popular rock songs including Foo Fighter’s ‘Pretender’, White Stripe’s ‘7 Nation Army’ and closed with a lively performance of Nirvana’s ‘Smells Like Teen Spirit’. Recreation Staff/Clerks, led by AIC Jacob Lawrence, were the ‘stage crew’ setting up the stage, instruments and equipment. Other clerks worked a beverage station and served popcorn.

Attending AIC’s were attentive and cheered for every song. During one song, Sean Riggs led the crowd in a rhythmed clap to support a solo singing part, which got everyone excited and involved. Band members wore Santa Hats in a festive gesture. Lead Singer Thomas Urvina, the newest member to the band, stated this concert was the first time he had ever sung in front of crowd, however the crowd cheered for him, and by the end of the concert he sung energetically and danced to the songs while singing.

As the concert ended, nearly the entire audience called for an encore and got up to shake hands and congratulate the band for their “awesome” and “kick-\$#@” performance. Multiple Staff members came in and clapped along with the songs. One AIC told a Recreation clerk the event made him feel like “we’re all real people” and “have something to live for”.

The concert program will continue with two other bands performing, one in January and the other in February.
