Beginning May 1st, aspirin will only be offered through an order from a provider or through commissary. For those patients who are suffering from mild to moderate pain from headaches, muscle aches, menstrual periods, colds and sore throats, backaches and other associated symptoms, ibuprofen and acetaminophen are available at the housing unit. In addition to calcium carbonate (Tums®) for acid indigestion, heartburn and upset stomach, these products are available for self-use. If your health care needs are of a greater need, please see your medical provider.

### **SRCI Physical Plant has an AIC Limited Maintenance Electrician (LME) Apprenticeship position that will be available in the near future.**

**In order to apply, all of the following criteria must be met (no exceptions):** Clear conduct (No Major DR or Program Failures) • Completed and passed Math 70 or above (Must show proof) • High School Graduate, GED, or above • Must already be housed in Complex 1A, 1B, 1C or Minimum • Classification 3 or less • No history of escape or arson • 10 years or less remaining on sentence • This program takes approximately three years to complete (4,000 program hours). If you are interested in this program and meet all of the above requirements, send a completed job application along with an Inmate Communication expressing your interest to Physical Plant (B344). The applications will be screened by members of the SRCI Journeyman Electrical Apprenticeship Subcommittee. Qualified applicants will need to pass a security screening before being contacted for an interview. Applicants will be subject to Drug testing. Applications will be accepted until May 12, 2025.

Qualified Candidates also need: \*Good communication skills with Staff, other AIC workers and Visitors, \*Ability to follow instructions, \*Patience, \*Ability and willingness to sanitize and deep clean, \*Be self-motivated, \*Knowledge of, and skills using equipment preferred, \*Food Service Handlers Card and Barista 101 training/testing will be required once selected \*Days/Hours may vary, \*PRAS Point range – 12 to 14 points\*
