Parameters for Transfer Requests

To eliminate some confusion regarding transfer requests, the Correctional Services team would like to let everyone know the parameters of transferring to different institutions. Here are the main parameters:
*Correctional Counselors can initiate an AIC transfer request when the AIC is less than 12 months to release if the AIC is releasing to a distant county (if there is no hold). *If an AIC applies for and is selected for a program or work opportunity at another facility and that facility reaches out to the counselor asking for a transfer, the transfer can be initiated. *The screening process for transfers takes time and the Correctional Counselor must receive clearance from multiple stakeholders before a transfer request is placed. *AICs cannot be placed on the transfer list if they have medical or program holds. *AICs cannot request specific institutions or when they transfer, and staff cannot share details regarding transfers with AICs for safety and security reasons. *There are long waitlists for minimum and releasing facilities. A transfer request can be in for quite some time before an AIC will transfer. *The Office of Population Management makes the final determination or approval for transfers. Correctional Counselors do not determine the timing of transfers. *STM, Special Housing, Medical, BHS, Security related, TASC, and OPM transfers are initiated and approved by those entities, not by the correctional counselors. This is what the ODOC rule states regarding Hardship Transfers: 291-034-0300: "While the department recognizes the importance of family and friends in the rehabilitation of inmates, the department is unable to grant transfer requests for the purpose of hardship or convenience."

Parent submitting the form must be the parent, or a principal parental figure of the child(ren) listed on the form. 4. There cannot be an order of protection or administrative rule prohibiting contact in place. 5. Parent must have legal authority to allow their child's information to be used by Prison Fellowship Angel Tree. **ALL APPLICATIONS ARE DUE BY WEDNESDAY, SEPTEMBER 17, 2025.**

Physical Plant Recruitment Opportunity!

SRCI Physical Plant has an opening on the Landscape Crew and Orderly. **In order to apply, all of the following criteria must be met (no exceptions) *Clear conduct for 1.5 years (no Major DR or Program Failures) * Must already be housed in Complex 1-A, 1-B, or 1-C * Classification 3 or less * No history of escape or arson * 10 years or less remaining on sentence.** Experience in landscaping, planting and maintaining lawns, shrubs and trees; coordination of the irrigation system, and systematic watering of all plant life. Also performs the duties of turf/plant care, equipment area maintenance/checks, and other duties as assigned. You must have a general knowledge of all various hand tools, work well with others, able to complete assigned tasks, and able to troubleshoot problems. —OR— Orderly experience: wash/sanitize toilets and sinks, restock disposables (paper towels, toilet paper, cups, soap, etc), clean mirrors/windows, ensure spaces are prepared for the next day by taking out trash, and other applicable custodial duties. The position also involves floor maintenance, sweeping, mopping, stripping, waxing, ability to lift heavy objects, and other duties as assigned. If you are interested in this program and meet all of the above requirements, send a completed Physical Plant Work Assignment Application; along with an AIC Communication expressing your interest to Physical Plant (B344). The applications will be screened by members of the Physical Plant staff. Qualified applicants will need to pass a security screening before being contacted for an interview. Applications must be received by July 31, 2025.
